Please read the following important dates, rules and guidelines carefully.

Important Dates:

- Artists' canvases will be stamped from **Friday, July 26, 2024 through Friday, August 9, 2024** at the Temecula Valley Museum, 28314 Mercedes St., from 10:30am 3:30pm (Closed on Monday). Participants are required to sign a waiver releasing the City from all liability.
- Artists can paint at the designated locations from the time their canvases are stamped until completed paintings are due on August 11, 2024 at the Temecula Valley Museum by 3:00pm.
- Judging will take place throughout the month of August. An awards ceremony and artist reception will be held on **Friday, September 20, 2024 from 5:30pm to 7:30pm** at the at the Temecula Valley Museum. **Awards will be announced at 6:00pm.**
- Eligible entries will be displayed at The Temecula Valley Museum in the **Ralph Love Plein Air** exhibition from Friday, August 16, 2024 through Sunday, September 22, 2024.
- All displayed entries will be available for **pick-up** from **Tuesday, September 24, 2024 through Tuesday, October 1, 2024** at the Temecula Valley Museum.

Thank you for participating in the 17th Annual Ralph Love Plein Air Competition.

Please read the following rules and guidelines carefully.

Rules and Guidelines:

- 1. By registering for the 17th Annual Ralph Love Plein Air Competition the **artist acknowledges** that they have read and understood the competition rules and guidelines.
- 2. All entries MUST be stamped prior to painting.
- 3. Artists must sign the "Art Loan and General Liability Waiver" in order for canvases to be stamped.
- 4. A stamp **will not** be provided on canvas stretcher bars or frames, no exceptions. A stamp **will not** be provided if the artist has begun painting the surface or canvas.
- 5. Entries **must** be created in the pure intent of outdoor, **on location**, plein air painting. At least 75% of the painting must be produced outdoors, in the spirit of plein air, at any of the following locations:
 - *Old Town, Temecula: Artist's Choice of Old Town Site
 - *Temecula Parks: Artist's Choice of park
 - *Temecula Wine Country: Artist's Choice of Winery
- 6. Entries produced using manipulated photographic processes, computer enhanced imagery or other non-plein air means **will not be accepted.** All entries must be painted in one of the following mediums: Water Color, Oil, Acrylic or Gouache.
- 7. Artists **must** complete and turn in the "Submission Inventory Form" along with all work being entered by **Friday, August 11, 2024, at 3:00pm.**
- 8. The entire back of the entry must be visible at submission. The **authentication stamp must be visible** on the back of the actual painting surface or canvas.
- 9. All paintings **must have a strong wire on the back** for hanging. The maximum size of the artwork, including framing, should not exceed 24" X 30".

Please read the following rules and guidelines carefully.

Rules and Guidelines Continued:

- 10. **Artwork CANNOT be signed** anywhere on the front of the work. This is to ensure impartiality when judging. **Artwork signed on the front of the work will be automatically disqualified.**
- 11. Each entry must have an Artist Identification Sticker (Artist Name, Title, dimension, media, etc.) on the backside of the piece at submission.
- 12. Due to the high volume of registrations for this event, **a maximum of 2 entries** may be submitted per artist.
- 13. In the event that entries exceed 65 pieces, **only the top scoring 65 entries will be displayed** in the museum exhibition due to space considerations. Artists will be contacted to pick up any remaining entries not displayed in the gallery.
- 14. Each participating artist is to pay the **non-refundable fee of Thirty Dollars and No Cents** (\$30.00). Due to the high volume of registrations for this event, a **maximum of 2 entries** may be submitted per artist.
- 15. Awards include: Life in Temecula / City Purchase Award (\$500), 1st Place (\$200), 2nd Place (\$100), and 3rd Place (\$75), Youth 14-17 (Art supplies basket), Youth 13 & under (Art supplies basket).
- 16. One prize per artist.
- 17. The winner of Life in Temecula will have the honor of judging the 18th Annual Ralph Love Plein Air Competition in 2025. As a "Best of Show" winner, the artist will be ineligible to enter the contest.
- 18. All entries in the Youth Categories that are under 18 must have a parent sign liability waiver.
- 19. All entries that do not follow rules and guidelines stated above will NOT BE ACCEPTED.

City facilities are not a public forum for the display of art and nothing contained in this policy is intended to be nor shall be construed as a policy establishing a public forum for the display of art at City facilities. The City reserves the right to cancel the exhibition/event at any time, with or without a statement of reasons. The City may rely upon the recommendations of art judges or art groups for recommendations of the art to be displayed at City facilities. In such cases the judges or art groups shall recommend several pieces for display from which the City may select the limited number of art pieces to be displayed. Art depicting specified anatomical areas and specified sexual activities as defined in Section 5.09.030 of the Temecula Municipal Code, or any of them, shall not be displayed in areas open to the public.

I realize reasonable precautions are taken to reduce any damage, injuries or hazard from this activity; however, in the event of an injury, I hereby waive, release and hold harmless from any liability for damages of personal injury including accidental death, as well as from claims for property damage which may arise in connection with the above named activity, against the City of Temecula, its elected and appointed officials, agents, employees and volunteers. The City of Temecula, Temecula Redevelopment Agency, and any all otherwise officially named sponsors shall not be responsible to compensate, indemnify, or pay damages to an applicant for any reason whatsoever.

Lender hereby releases and holds the City and its Agencies harmless from any liability for damage to or loss of the Work not covered by City's insurance.
